DESCRIPTION

HOW TO USE

1 sachet per day, preferably away from meals.

PACKAGE

30 sachets of 5,5 gr

STORAGE

Store in a cool dry place: after opening the product is moisture sensitive, keep tightly closed.

The expiry date refers to the unopened product, properly preserved.
