DESCRIPTION

Realfibre is a food supplement containing fibres that promote the maintenance and development of healthy intestinal flora.

They can be useful in cases of constipation, dysbiosis due to incorrect nutrition or from taking antibiotics.

The main characteristics of prebiotics are resistance to digestive processes in the upper gastrointestinal tract and selective fermentation for one or a limited number of microorganisms in the intestinal flora.

Their consumption increases faecal mass and can therefore be helpful in combating constipation.

Inulin is an oligosaccharide consisting of long chains of fructose.

Its special characteristic is that it promotes the presence of Bifidobacteria in the intestine.

All in all, these effects result in improved intestinal function in terms of nutrient absorption and an aid to intestinal transit, promoting the well-being of the intestine and thus of the entire organism.

Realfibre is a dietary fiber supplement (Inulin and apple fiber) with fructoligosaccharides which is required in all cases of increased requirements or reduced intake of these nutrients.
