Merr.) dry extract stem 100mg/square 8g, Prickly pear (Opuntia ficus-indica (L.) Mill.) leaf dry extract 75mg/square 8g, Green tea (Camellia sinensis (L.) Kuntze) leaf Dry extract 100mg/square 8g, Griffonia (Griffonia simplicifolia (DC.) Baill.) Seeds Dry extract 25mg / square 8g.
