DESCRIPTION

Liquid dietary supplement **based on vitamins and plant extracts that can promote circulatory function and regularity of blood pressure.**

Olive leaves promotes: metabolism of carbohydrates and lipids; normal blood circulation; regularity of blood pressure; antioxidant

The **red aubergine fruit** has a supportive and restorative action and promotes regularity of blood pressure.

Sweet potato tuber promotes: Carbohydrate metabolism. Metabolism of triglycerides and cholesterol. Modulation/limiting of nutrients absorption.

INGREDIENTS

Water, Olive extract idroglicerico (*Olea europaea L. leaves; Water; Glycerol*), Turmeric extract hydroglyceric (*Turmeric (Curcuma longa L.) rhizome; Water; Glycerol*), Olive tree (*Olea europaea L. leaves Dry extract D/E 4:1*), Solanred® Red Aubergine (*Solanum aethiopicum L. dried fruit extract D/E 5-6:1*), Aroma, Preservative (*Potassium sorbate*), Sweet potato (*Ipomoea batatas (L.) dry tuber extract D/E 4:1*), Sweetener (*Sucralose*), Vitamin E (*DL-alpha-tocopheryl acetate*), Acidifying (*Citric acid*), Vitamin D3 (*Cholecalciferol*), D/E: drug/extract.

HOW TO USE

Shake well before use. It is recommended to take 40 ml of the product, equal to 1 scoop, once or twice a day, even diluted in water or fruit juice.

PACKAGE

500 ml

STORAGE

Keep in a cool and dry place.

Do not use after the deadline for storage.

The minimum storage term refers to the product in an intact and correctly stored package.

Any sediment or suspended particles are a natural characteristic of the product.

Once opened, keep the bottle in the refrigerator and consume within 30 days.
