INDICATIONS

Kalosnep sachets is a dietary supplement made up of extracts from 7 plants and Coenzyme Q10. Cassia Nomame and guarana may be useful to maintain the physiological balance of the body weight, when taken together with a suitable lowcalorie diet and following a healthy lifestyle with a good level of physical acti-vity. The Emblica can promote metabolism of carbohydrates; Curcumin, Berberine and Ginger are useful for digestive and liver function; Piper nigrum can promote regularity of bowel movements and digestive function. Curcumin, the Berberine and coenzyme Q10 are dissolved in cocoa butter and incorporated into the final product with a unique micro-emulsion technology. Thanks to this particular technique of working the active ingredients present in these extracts are more biodisponibili.
